Your support as Fellows, donors, and NYSBA members helped move us in new directions and keep us on course to continue to fulfill our mission. Lindenauer and Getnick Honored by Foundation

2023 began with the presentation of the Foundation's most prestigious awards to two legal community leaders during the Annual Assembly and Meeting of the Fellows.

Susan B. Lindenauer Receives Foundation's Lifetime Achievement Award



Susan Lindenauer received the award in recognition of her extraordinary professional achievements and commitment to the legal profession's highest ideals. Her efforts are reflected in her life of selfless dedication to the rule of law and enhancement of access to justice. "Susan exemplifies the definition of a Fellow," said Chair of the Fellows, James R. Barnes. "Her dedication to the Foundation, civil legal services, and the Board is unparalleled. It was an honor to recognize her service, her passion, and her commitment to the legal profession and public service."

Lindenauer said, "I am honored to receive The New York Bar Foundation Lifetime Achievement Award. My professional career has focused on improving access to justice and supporting the rule of law which is fundamental to our society and our profession. My long-term commitment to the vision and mission of the Foundation, which focuses on both of these, is imperative and is in keeping with my lifelong passion of making a difference."

Lindenauer began her legal career at Cleary, Gottlieb as one of only three female associates. Subsequently, she worked at The Legal Aid Society, tirelessly working to ensure that the indigent received high quality legal representation until her retirement thirty-eight years later.

Lindenauer has dedicated her life to the pursuit of equal justice through her volunteer efforts as well, holding leadership positions and serving on several New York State Bar Association committees. As chair of the Legal Aid Committee, she led the effort to prepare the first study of the unmet need for civil legal services in New York State. Under her leadership, the Task Force on the Family Court completed a report that was instrumental in getting legislation passed and enacted to increase the number of judges in New York's severely under resourced Family Court. More recently the Committee on Families and the Law issued a Report on Racial Justice and Child Welfare which was adopted by the New York State Bar Association. Lindenauer also serves on several additional community boards.

Lindenauer has been an active member of the Foundation's Board of Directors for twenty-five years. She served as vice-chair and chair of the Fellows; and currently serves as chair of the Audit Committee, the Cy Pres and Special Gifts Committee, and the Personnel Committee. She is also the Foundation's Chief Publicity Officer. Lindenauer has been a Fellow of the Foundation since 1985.

Michael E. Getnick Receives Foundation's President's Award



Michael E. Getnick, of Getnick Livingston Atkinson & Priore, LLP Utica, was presented with the Foundation's President's Award. The Award is presented to someone who has made an indelible impact on the law and served as a significant role model in New York and the broader legal community. Foundation President, Carla M. Palumbo, President & CEO The Legal Aid Society of Rochester, said, "Michael Getnick is the embodiment of what we should all strive for as members of this profession. He has been a

role model throughout New York State and his dedication is an inspiration."

Getnick said, "Whatever I have accomplished has been made possible by the efforts of others through their support, encouragement and commitment to the causes I have identified with and pursued in my practice of law. I share this award with them and thank them for their dedication to making the rule of law a reality in the lives of so many."

After receiving his law degree from Cornell Law School, Getnick practiced as a trial attorney with the Legal Aid Society of Oneida County. He then served on the Society's Board of Directors and as President of the Board when it became the Legal Aid Society of Mid-New York covering many counties in the 3rd and 4th judicial districts. He then served as a law clerk for a State Supreme Court Justice in the 1970s. Getnick entered private practice in 1974 and has successfully represented a range of clients in complex litigation and business matters. In 1986, Getnick was a founding partner of Getnick Livingston Atkinson & Priore, LLP, which

remains the largest law firm in his adopted hometown of Utica, New York. Since 1988, Getnick has been of-counsel to the Manhattan-based firm of Getnick & Getnick, which specializes in representing whistleblowers in anti-fraud cases.

Getnick litigated the first successful racial balance case for public school districts before the Commissioner of Education. He also litigated the only annexation case between two counties before the New York Court of Appeals.

Patrick G. Radel, Partner at Getnick Livingston Atkinson & Priore, Utica, said, "Michael Getnick's personal character and professional accomplishments represent a lawyer living his calling and embodying the Foundation's ideals. His career has been marked by personal dedication to lawyer independence, ethical behavior, self-renewal, and the integrity of the profession. He is only the second attorney from Oneida County to serve as president of the New York State Bar Association."

In addition to serving as the 112th President of the New York State Bar Association, Getnick also served on the House of Delegates, and Committee on Diversity and Leadership and chaired the Committee on Court Operations. As president, he created the Association's Trial Lawyer Academy working with the leaders of the Young Lawyers Trial Section, Sherry Levin Wallach, and Tucker Stanclift, who established the Academy's program.

Getnick has been a Fellow of The New York Bar Foundation since 1995, and has served as president of the Oneida County Bar Association and chaired numerous committees. In 2017, Getnick was appointed as special ombudsman for the United States Bankruptcy Court for the Northern District of New York, reporting to the Chief Bankruptcy Judge on concerns related to court operations. Getnick is committed to his community and to access to justice. He was recognized by the New York State Bar Association in 1988 with a pro bono service award. His community activities include service on the boards of several organizations.

Your Donations at Work - Fighting Homelessness with Housing Works, Brooklyn

Ms. X found herself homeless with two small children, no resources or income, and nowhere to stay. A fellow church member took pity on her and allowed her and her children to sleep on the living room floor of her one-bedroom apartment. It was a dreadful situation: among other issues, Ms. X's friend worked nights and slept during the day, forcing Ms. X to somehow keep her young children quiet throughout the day while her friend slept. Ms. X secured a housing voucher that would pay full market rent directly to the landlord and end her homeless nightmare. She applied to a housing complex but was rejected and informed that even with a full voucher, she needed to earn \$62,000 in income, an unjustifiable requirement considering her full voucher. Housing Works helped Ms. X secure an affidavit attesting that the complex had never accepted a single CityFHEPS voucher holder, even though the voucher could easily cover the rent. Housing Works and co-counsel secured a temporary restraining order and a preliminary injunction to compel the complex to end this discriminatory practice, process Ms. X's application, and house Ms. X and her children. After full briefing and oral argument, Housing Works secured the first-ever decision that landlords cannot reject those with full vouchers based upon minimum income requirements. Following this ruling, the complex processed and approved Ms. X's application. She moved into a lovely three-bedroom apartment overlooking a scenic park. In short order, Ms. X and her children went from homelessness to private bedrooms.

"Housing Works is proud to champion the cases of clients who struggle to maintain their homes in the face of substandard conditions and eviction proceedings, which threaten their health and lives and which could leave them homeless and removed from vital support networks. Without the New York Bar Foundation, we would not be able to dedicate the resources necessary to sustain our client-centered practice. Your Donations at Work - Helping to Support Family Stability With JustCause, Rochester

Maria* had been caring for her seven-year-old nephew for almost a year when she reached out to JustCause for assistance in filing for custody of the child. Maria disclosed to JustCause staff that her nephew's parents were struggling with addiction and lacked stable housing or reliable income, rendering them incapable of adequately caring for their child. The mother had recently begun threatening to take the child, which Maria worried would put her in an unsafe environment and disrupt her schooling. JustCause invited Maria to a Family Law Custody Clinic where she met with a pro bono attorney who provided her with advice and counsel on her situation and assisted her with completing a petition for custody, which ultimately helped her access the courts to seek custody of this child.

"The Family Law Custody Clinic Program has played a crucial role in addressing a significant gap within the justice system. Prior to filing a Petition in Family Court, individuals often lack the opportunity to connect with a Public Defender or other court-appointed attorney. Consequently, many individuals in need of legal advice about their rights do not receive the help they need, creating a barrier to their access to the courts. The Merril and Hope Sobie Fund

justice for children through the Foundation's grant program. Professor Sobie is Professor of Law Emeritus at Pace University Elizabeth Haub School of Law. **"The**

Bar Foundation has successfully advanced children's rights and interests through generous grants and programs," said Professor Merril Sobie. "I am happy to support and expand the Foundation's commitment by establishing this fund, which is even more meaningful now that Hope has passed away."

Professor Sobie teaches Jurisprudence, Children and the Law, Advanced Family Law, and Comparative Family Law at Pace University Elizabeth Haub School of Law. He has authored two books. New York Family Court Practice and The Creation of Juvenile Justice: A History of Children's Law, has published the official McKinney's Commentaries to the Family Court Act and the Domestic Relations Law, and has written numerous articles concerning children's laws. He co-authored the New York State Bar Association Study of the Legal Representation of Children,

drafted the official Bar Association Standards and Commentaries for Representing Children, and drafted the New York Juvenile Delinquency Code. He is Past-Chair of the New York State Bar Association Committee on Children and the Law and is a Fellow of the New York Bar Foundation.

The Honorable Theresa B. Whelan Memorial Fund for Families and Children



The fund was established to pay a lasting tribute to the late Honorable Theresa B. Whelan.

who served as a Suffolk County Family Court judge as well as the county's Surrogate's Court judge. Donations to the fund will help provide Foundation grants to New York nonprofit organizations whose mission includes providing assistance to local families and children in need.

Theresa Whelan always knew she wanted to be in public service. As a young attorney fresh out of Albany Law School, she began her legal career in 1988 as a Suffolk County Assistant County Attorney. She entered the court system in 1990 as a senior law clerk to Supreme Court Judge Eli Wagner, in Nassau County. She went on to work as a principal law clerk in Suffolk County

for Supreme Court Judge Mary M. Werner and, later, Supreme Court Judge William B. Rebolini. During her 17 years in the Supreme Court, she worked in nearly every part, including civil litigation, quardianship, tax certiorari and condemnation cases as well as matrimonial matters. Theresa Whelan became Suffolk County's Surrogate in 2019, presiding over proceedings involving wills, trusts and estates as well as guardianship matters. She retired in the summer of 2022. marking 32 years with the New York State court system. Known for her commitment to improving court practices to better

serve the needs of the public, Theresa Whelan mobilized several initiatives that helped families and children and that expanded access to justice for all court users. She was a catalyst of the FOCUS (Family Overcoming Crisis through Unified Services) initiative, a program that expedites access to services that address the trauma and developmental needs of children and parents in the court system.

She also served as lead judge of the Suffolk County Child Welfare Court Improvement Project, part of a statewide initiative to address court practices in cases where the court has removed children from their parents' care. In 2016, Chief Administrative Judge Larry Marks appointed her to the Family Court Advisory and Rules Committee. In 2018, former New York Court of Appeals Chief Judge Janet DiFiore appointed her to the New York State Commission on Parental Representation, which is tasked with holding public hearings and reporting on the status and quality of lawyers representing parents in child welfare cases. Since 2016, Theresa Whelan had been the chair of Suffolk County's Attorneys for Children Advisory Committee, which is responsible for considering the qualifications of new applicants to the Attorneys for Children panel as well as reviewing the recertification applications for existing lawyers.
